

## **The Ausbuild Dolphins NRL Community Partner Opportunity**

### **Frequently Asked Questions**

#### **General**

**Q.** What is the Opportunity?

**A.** The Ausbuild Dolphins NRL Community Partner Opportunity has been set up as a way for local community groups to benefit from Ausbuild's sponsorship of the Dolphins NRL. The Opportunity allows select community groups to attend a home game of the Dolphins NRL and utilise this Opportunity to either give back or as a fundraising opportunity.

**Q.** What does a Successful Applicant receive?

**A.** A Successful Applicant will receive up to 150 complimentary tickets to a Dolphins NRL home game in 2026 and successful applicants will have the opportunity to be involved with the prestigious Guard of Honour and select applicants the opportunity to fundraise leading up to the game.

**Q.** How many opportunities are there?

**A.** There are a total of six Dolphins NRL home games in the 2026 season for local community groups.

**Q.** Can a successful applicant pick the home game they want to attend?

**A.** No. The game allocations will be determined (in its absolute discretion) by Ausbuild. Ausbuild will take into consideration any preferred home game identified by a Successful applicant in their application but their preference is not guaranteed.

#### **Eligibility**

**Q.** Can Ausbuild advise me whether I am eligible to apply for the opportunity?

**A.** It is up to each Applicant to determine whether it meets the eligibility requirements of the Opportunity. Eligibility requirements are set out in the *Ausbuild Dolphins NRL Community Partner Opportunity Terms and Conditions (2026)*.

**Q.** How do I know whether my community group or organisation is a not-for-profit?

**Q.** How do I know whether my organisation is incorporated or unincorporated?

**Q.** My organisation is not registered for GST, is it eligible to apply for the Opportunity?

**A.** Yes, it is not mandatory to be registered for GST to be eligible to apply.

**Q.** The organisation I represent is not based in the Moreton Bay Local Government Area, however, the purpose of my organisation is to provide a benefit to the community in the City of Moreton Bay - is the organisation eligible to apply for the Opportunity?

**A.** Yes. As long as the organisation itself is located in or the organisation's main activities are delivered to the community within the Moreton Bay Local Government Area, your organisation is eligible to apply for the opportunity.

**Q.** The organisation I represent is based in the Moreton Bay Local Government Area, however, the purpose of the organisation is to provide a benefit to a community outside of the City of Moreton Bay - is the organisation eligible to apply for the Opportunity?

**A.** No. The opportunity is intended for organisations that contribute to or provide a benefit to the community within the City of Moreton Bay. The purpose of the organisation must be carried out within or for the benefit of the community in the Moreton Bay Local Government Area.

**Q.** My organisation does not have an Australian Business Number (ABN), is it eligible to apply?

**A.** Yes.

**Q.** My organisation does not have public liability insurance, is it eligible to apply?

**A.** Yes. However, all risk and liability arising from the activities of your organisation remain with your organisation.

**Q.** What happens if any details included in my organisation's application change after I have completed and submitted an Application?

**A.** Please email [marketing@ausbuild.com.au](mailto:marketing@ausbuild.com.au) with your organisation's new details.

## How to Apply

**Q.** How long do I have to apply for the Opportunity?

**A.** Applications can be submitted from 9.00am (AEST) 29 January 2026 until the close of applications at 5:00pm (AEST) on 13 February 2026.

**Q.** How many Applications can my organisation submit?

**A.** You can submit a maximum of two (2) Applications for the 2026 Opportunity.

**Q.** Can my organisation submit a hard copy Application?

**A.** No, all Applications must be made via the online submission form at <https://www.ausbuild.com.au/dolphins-nrl-2026>

**Q.** Can I contact Ausbuild to discuss whether my organisation's proposed Application meets the requirements of the Opportunity?

**A.** No. In fairness to all Applicants, Ausbuild will not discuss any organisation's Application with them before it is submitted. If your organisation requires clarification on an aspect of the online application form, and your questions are not answered by first reading:

**Q.** Will I receive an email confirmation that my organisation's Application has been successfully submitted?

**A.** Yes. Once you submit your organisation's Application, you will receive an email confirming the form has been successfully submitted.

## Assessment

**Q.** How will my Application be judged?

**A.** An Applicant must be able to demonstrate that it can satisfy the Eligibility and Selection Criteria included in Annexure A of *The Ausbuild Dolphins NRL Community Partner Opportunity Terms and Conditions (2026)*

**Q:** Who judges my Application?

**A:** The Judging Panel is made up of select members from Ausbuild and the community.

**Q.** What is the aim of the Opportunity?

**A.** The aim of the Opportunity is described in Part A – General Terms of *The Ausbuild Dolphins NRL Community Partner Opportunity Terms and Conditions (2026)*.

**Q.** How do I know if my application has been successful?

**A.** All successful and unsuccessful Applicants will be notified via email or phone within 30 days of the end of the Verification Period as detailed in Item 4 of the Schedule of *The Ausbuild Dolphins NRL Community Partner Opportunity Terms and Conditions (2026)*, and all successful Applicants will be announced on Ausbuild's website and Facebook page.
